Role Purpose

The Child and Youth Therapeutic and Wellbeing Practitioner supports children and young people affected by family and domestic violence, including those with diverse and intersecting needs, are able to easily access age-appropriate therapeutic support to enhance their safety, recovery and healing. This is through a mix of one-to-one and family-based case management and therapeutic healing/counselling methods to support safety, recovery and healing for children and young people who are victim survivors of family violence.

Role requirements

- Deliver individual and group therapeutic interventions for children and young people impacted by family and domestic violence.
- Conduct comprehensive assessments to identify needs, risks and safety to inform tailored care plans.
- Develop and implement therapeutic, trauma-informed, safety and support plans in collaboration with families.
- Provide goal-focused therapeutic counselling and parenting support using evidence-based techniques such as play and art therapy.
- Maintain accurate, confidential records of sessions, assessments, and plans.
- Coordinate referrals and advocate for children, young people and their families with external services.



- Collaborate with parents, caregivers, schools, and professionals to support wellbeing and recovery for children and young people.
- Respond promptly to crises in accordance with organisational policies.
- Monitor and evaluate intervention effectiveness, adjusting approaches as required.
- Stay informed on current research, best practice frameworks, and emerging therapeutic methods for children, young people and families impacted by family Violence.
- Educate caregivers and schools on supporting children's emotional wellbeing and recognising them as victim-survivors.

Health, safety, security and risk management

- Be a role model for safety and security and comply with all workplace safety policy, procedure, work instructions and training.
- Always act safely and consult line supervisor when necessary.
- Report all incidents, injuries and potential hazards in a timely manner.
- Participate in, and contribute to, health and safety awareness and improvements.
- Be aware of, document and manage the risks associated with your team's programs and workplaces and ensure appropriate elimination or mitigation measures are applied.
- Complete either a home visit and outreach risks assessments to assess risk before each visit with a child, young person or family to ensure safety.
- When visiting a child, young person or family alone, the ADT lone worker app must be operated.

Child protection and safeguarding requirements

- Maintain a child safe environment at the workplace and safeguard children's rights, always acting in the best interests of children
- Comply with the <u>Child Safeguarding Policy</u> & <u>Code of Conduct</u>
- Demonstrate the highest standards of behaviour towards children in both your private and professional life
- Never abuse the position of trust that comes with being a part of the Save the Children family
- Always maintain a safe and positive relationship when working with children and young people
- Respond to any concerns for the safety or wellbeing of a child in a program in accordance with internal reporting processes

Essential knowledge or experience

- Understanding of the impacts of Family and Domestic Violence (FDV) on children's development, behaviour, and capacity for self-regulation
- Understanding of how FDV affects attachment, family functioning, and caregiving relationships
- Knowledge of developmental stages in children and how these influence needs, behaviour, and responses to stress
- Knowledge of trauma in children and young people within the context of FDV, including trauma responses and long-term effects
- Knowledge of protective behaviours and strategies that support the safety and wellbeing of children and young people
- Experience working with children and adolescents in a therapeutic setting, or experience in a counselling/therapeutic role with children and young people
- Ability to work collaboratively with staff and management to develop resources that enhance service delivery
- Ability to engage with First Nations and CaLD children and young people in a culturally safe, respectful, and strengths-based manner



- Ability to build and maintain effective relationships with relevant stakeholders to enhance service access and outcomes
- Ability to commit to and facilitate genuine children's participation in the design and delivery of service
- Ability to conduct risk assessments and develop age-appropriate safety plans for children and young people

Desirable knowledge or experience

• Degree/Diploma/Certificate qualification in a relevant field such as Counselling, Social Work, Human Services, Social Sciences, or Community Services, or significant experience working in the Community Services sector with children, young people and their families.

Required qualifications and/or accreditations

• Tertiary qualification in a relevant field such as psychology, social work, or counselling
