#### INTRODUCTION:

Save the Children International (SCI) is the world's largest independent child rights organization, making a difference to children's lives across 100+ countries. SC thematic areas include Education, Health, Child Protection, Disaster Risk Reduction, and Humanitarian Response.

The Pacific Coalition for the Advancement of School Safety (PCASS) programme (2022–2025) is funded by the New Zealand Ministry of Foreign Affairs and Trade. It brings together various stakeholders across the Pacific region to implement comprehensive school safety initiatives. This role supports Providing technical support and capacity-building to Pacific Island countries on Disaster Risk Reduction (DRR), school safety, and climate resilience.

#### **ROLE PURPOSE:**

The School Safety and DRR Support Officer will work closely with the Project Coordinator and the Regional Lead to provide technical support and capacity-building to stakeholders at national and regional levels. The role will focus on implementing training programs, strengthening technical capacities in Disaster Risk Reduction (DRR), and ensuring that Pacific schools are better prepared for disasters and risks. The officer will contribute to the delivery of Outputs 1 and 2 of the PCASS project, focusing on supporting school safety implementation across the region.

# **Role requirements**

## KEY AREAS OF ACCOUNTABILITY

- 1. Training and Capacity Building on DRR and School Safety
  - Develop and implement tailored training programs on DRR and comprehensive school safety for stakeholders, including teachers, school administrators, education ministries, and local communities.
  - Organize capacity-building workshops focused on strengthening technical skills in risk assessment, emergency preparedness, school disaster management, and safety protocols.
  - Collaborate with national governments and regional bodies to ensure training materials are adapted to local contexts and needs.
  - Support the creation of training tools, manuals, and guidelines to facilitate the institutionalization of DRR and school safety practices.
  - Assist in the delivery of technical assistance to countries to ensure their school safety policies and plans align with the Sendai Framework for Disaster Risk Reduction and the Framework for Resilient Development in the Pacific (FRDP).

#### 2. Technical Support to Stakeholders

- Provide ongoing technical support to ministries of education, school leaders in the development and implementation of school disaster risk management plans.
- Collaborate with the Project Coordinator and Regional Lead to ensure that technical resources, including toolkits and guides, are accessible and effectively utilized by stakeholders.
- Provide guidance on the use of school safety self-assessment digital app for structural safety of schools, working with local authorities and engineers to improve school facilities where necessary.
- Support Pacific Island countries in monitoring and evaluating the effectiveness of their school safety and DRR initiatives, providing recommendations for improvements where needed.

## 3. Support for Policy Development and Advocacy

- Assist in the development of national and regional policies that support comprehensive school safety, disaster risk reduction, and climate resilience.
- Work closely with the Advocacy, MEL and Communications Coordinator to advocate for the integration of DRR and safety measures into education sector plans and policies at the national level
- Contribute to the development of advocacy materials that highlight the importance of DRR and school safety, using evidence from project outcomes to influence policymakers.
- Participate in key regional forums and meetings to promote school safety practices and share lessons learned from PCASS project activities.

## 4. Monitoring, Evaluation, and Learning (MEL)

- Support the development of monitoring and evaluation tools to track the progress and impact of DRR and school safety initiatives.
- Contribute to periodic evaluations of training programs, collecting feedback from participants to enhance the effectiveness of capacity-building efforts.
- Assist in preparing project reports, capturing key achievements, and documenting best practices for regional dissemination.
- Work with the Project Coordinator to capture lessons learned from training and technical support activities, ensuring continuous improvement of DRR and school safety interventions.

# 5. Knowledge Sharing and Engagement

- Support knowledge sharing among Pacific Island countries, ensuring the dissemination of successful DRR strategies and school safety interventions.
- Organize and facilitate peer-learning exchanges and virtual knowledge-sharing events to strengthen the capacity of regional stakeholders.
- Develop content for case studies and success stories that showcase the impact of training and technical support on school safety and disaster risk reduction.

## Health, safety, security and risk management

- Strong organizational skills with the ability to manage multiple training events and technical support initiatives simultaneously.
- Excellent interpersonal and communication skills, with the ability to engage and collaborate with diverse stakeholders.
- Proficiency in MS Office and other relevant software for training and reporting.

## Desirable knowledge or experience

- Experience working in the Pacific region or with education-related DRR initiatives.
- Familiarity with regional education and safety frameworks such as PacREF or the Framework for Resilient Development in the Pacific.
- Experience in working with government ministries and local authorities on DRR and school safety policy development.

• Bachelor's degree in Disaster Risk Reduction, Education, Social Science, or a related field.
