CHILD SAFEGUARDING

As part of these responsibilities consultant will support the establishment of child safeguarding systems, promote a culture of keeping children safe, and ensure that potential harm to children (by our own staff and/or as a result of how we do our work) is identified and addressed on an ongoing basis. The post holder should report and respond to interventions as determined by position related responsibilities identified in the SCA Child Safeguarding Policy and Code of Conduct.

INTRODUCTION

Save the Children Australia (SCA) works with the Save the Children global movement to expand climate change action and drive a strategy for impact for the world's most climate vulnerable children. Through its accreditation to the Green Climate Fund (GCF), SCA has developed a large portfolio of Locally Led Adaptation and climate change and health and education projects.

The education sector is increasingly exposed to climate risks driven by climate hazards. The changing climate is already threatening children's right to quality, safe, and inclusive education. Climate change threatens to make it harder for children to complete their education without disruption and remain safe and protected. The role of the education sector in climate action has so far been overlooked, with minimal climate finance flowing to increase the sector's resilience. In response to this SCA intends to develop two climate and education projects, in Iraq and Papua New Guinea (PNG), building on our recently approved Building Resilience of Children and Communities through the Education Sector (BRACE) project.

ROIF

This role will coordinate the development of high quality GCF concept notes for these two programmes, working with country offices (CO's), the Climate Change Division (CCD) and Pacific (for PNG) and Global (for Iraq) teams. The key accountabilities include:

- Manage concept note development in accordance with GCF requirements and SCA best practice including costing processes
- Support country offices in stakeholder consultation and management to ensure alignment with government priorities and identify strategic implementing partners and co-financers.
- Proposal writing

Depending on performance and the approval of the concept notes by GCF, the position may be extended using project preparation facility funding to coordinate development of full funding proposals.

MAIN RESPONSIBILITIES

The position is expected to coordinate the development of GCF concept notes for climate and education proposals in Iraq and PNG, aligned with national strategies and priorities, compliant with GCF requirements, and building on SCA technical frameworks in climate and education.

Proposal development

- Manage and oversee concept note development for climate and education projects in Iraq and PNG. This includes writing and editing, coordinating with CCD, Pacific, Global and country offices technical, and finance teams and overseeing costing.
- Ensure application of consistent technical framework informed by Climate Smart Education Systems Initiative (CSESI) and BRACE, as well as GCF requirements.
- Ensure all Business Development processes as listed in the Program Implementation Manual are followed.
- Proactively guide and support Programme Development & Quality and Techincal Expert teams where necessary to rigorously assess the strengths and weaknesses of potential strategic partnerships for programme development and implementation.

Relationship Management

- Ensure teams have best practice approach and system to planning and undertaking stakeholder engagement.
- Support the relevant country offices' Country Director, PDQ Director, and technical teams to build strong relationships with National Designated Authorities, Executing Entities, Implementing Entities, Direct Access Entities (current or potential) and potential co-financers.
- Provide GCF compliance advice to country offices.
- Collaborate and coordinate with the account group to explore cofinance opportunities.



Capability Strengthening

- In collaboration with CCD, support country offices' TE, Finance, PDQ staff with capacity building around GCF programme management cycle and compliance requirements.
- Establish continuous learning efforts including facilitating after action reviews and providing presentations/web events in order to implement best practices and learn from process so future BD efforts are improved.

Additional job responsibilities

The duties and responsibilities as set out above are not exhaustive and the role holder may be required to carry out additional duties within reasonableness of their level of skills and experience.

WORKING CONDITIONS

The role is home based in a time zone that facilitates working with Iraq and Papua New Guinea as well as the Climate Change Division in Australia and UK. Travel to Iraq and/or Papua New Guinea may be required.
